Important Dates

- September 18, M-F, 8-4:30: Absentee in-person voting at the Government Center begins
- September 18: First absentee ballots mailed out
- October 13: Voter Registration Deadline
- In Person/By Mail: 5:00 p.m. Online: 11:59 p.m.
- October 23: Deadline to apply by mail, fax and online to receive an Absentee Ballot:
- application must be received in the Fairfax Office of Elections by 5:00 p.m.
- **October 14-31**: Vote absentee early/in-person at satellite locations.
- November 2, 2pm: Last day to apply for an emergency absentee ballot (restrictions apply).
- November 3, 7p.m.: Deadline to hand deliver absentee ballots to Office of Elections.
- **November 3:** Absentee ballots MUST be postmarked by this date. Mailing it earlier is recommended to avoid any delays related to mail delivery
- November 6: Absentee ballots mailed in must be received by noon and postmarked by Nov. 3.

VOTE EARLY BY MAIL USING ABSENTEE BALLOT

October 23: Deadline to apply by mail, fax and online to receive an Absentee Ballot: application must be received in the Fairfax Office of Elections by 5:00 p.m. November 3: Absentee ballots MUST be postmarked by this date.

Mailing it earlier is recommended to avoid any delays related to mail delivery **November 6:** Absentee ballots mailed in must be received by noon and postmarked by Nov. 3.

> It's no longer necessary to provide a reason for voting early. You may apply now to receive an absentee ballot.

EARLY VOTING BY MAIL

- You may apply online for an absentee ballot through either <u>https://www.elections.virginia.gov/citizen-portal/ OR www.vote.org</u>
- Or you may get an application at any Fairfax County Public Library, from the Government Center, or print the <u>application</u>. Or you may also call 703-222-0776 (TTY 711) or email <u>absenteeballot@fairfaxcounty.gov</u> to request that an absentee ballot application be sent to you.
- The application can be returned by *Scanning the completed application and emailing it to <u>absenteeballot@fairfaxcounty.gov</u> OR *Faxing it to the Office of Elections at 703-324-3725 OR *Mailing it to the Office of Elections at Box 10161. Fairfax. VA 22038 (please allow enough time for the office of Elections)
 - *Mailing it to the Office of Elections at Box 10161, Fairfax, VA 22038 (please allow enough time for it to be received by the deadline)
- Once your application is received through any of these means, a determination will be made as to whether you qualify to vote absentee by mail (certain restrictions apply, including that you must have voted in person previously at your current address).
- Absentee ballots will be mailed beginning **Sept 18** for those whose applications have been approved.
- Absentee ballot applications will be processed in the order in which they are received.
- Absentee ballots MUST be postmarked no later than **Nov. 3** and MUST be received no later than **Nov. 6** at noon, **but mailing it earlier is recommended to avoid any delays related to mail delivery.**
- If you are concerned about mailing delays, drop boxes will be available inside all early voting (10/14-10/31) satellite locations.

You may have received a mailer from the "Center for Voter Information" (CVI) containing an application to request mail-in (absentee) ballots for the Nov. 3 election. The application was pre-printed with voters' names, addresses, etc. However, the pre-printed return envelopes were not addressed correctly.

If you completed and mailed this CVI application, you can expect to receive an absentee ballot. All registrars' offices have agreed to work together to ensure that each application gets to the right place.

VOTE IN PERSON EARLY (ABSENTEE)

EARLY VOTING IN-PERSON

- September 18-October 31, M-F, 8-4:30: Early voting/absentee in-person voting at the Office of Elections, 12000 Government Center Pkwy., Fairfax, VA
- The Office of Elections will remain open for business during its regular office hours,
- Voting October 14-31 at 14 satellite locations around the county (see below).
- The final day to vote absentee in person is **Saturday**, **October 31st**.
- When you arrive at the early voting site you will first be given an absentee ballot application. After you have completed that, you will be given a ballot. Curbside voting will be available if you are age 65+ or have a disability.
- Voter ID requirements apply for all in person voting. As of July 2020, photo ID is no longer required. For a list of acceptable forms of ID, see <u>https://www.elections.virginia.gov/registration/photo-ids-required-to-vote/</u>

ABSENTEE VOTING BEGINS:

- September 18 at the Fairfax County Government Center
- October 14 Satellite locations open

These locations are currently proposed to be open weekdays from 1 to 7 p.m., and Saturdays from 9 a.m. to 5 p.m. However, the Fairfax County Electoral Board may decide to adjust these hours later this summer based on the interest in absentee voting by mail. 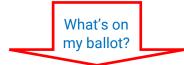




VOTE IN PERSON ON NOVEMBER 3

VOTING ON ELECTION DAY

- Election Day is Tuesday, November 3, 2020.
- Polling hours in Virginia are 6:00 a.m. until 7:00 p.m. As long as a voter is in line by 7:00 p.m., the voter will be able to vote.
- Curbside voting will available if you are age 65+ or have a disability.
- Although photo ID is no longer required, you must still provide proof of identity. Acceptable forms of ID are listed on the page five.
- If you cannot locate your polling place or if you have any questions about where you should vote on election day please visit <u>https://www.fairfaxcounty.gov/elections/precincts</u> or call the **Fairfax Office of Elections at 703-222-0776** (TTY 711).
- A Drop Box will be provided inside each Voting Precinct for any Absentee/Mail-in Ballot in its appropriate sealed envelope

IMPORTANT INFORMATION

VOTER PROOF OF IDENTITY

Whether you are voting early in person or voting on Election Day, Virginia law requires you to show one acceptable ID to vote. As of July 2020 a photo ID is no longer necessary.

The following forms of ID are acceptable:

- Voter confirmation documents mailed to you when you registered to vote
- Virginia driver's license*, DMV issued ID, or Virginia Voter Photo ID card
- United States passport or other U.S. or Virginia government-issued photo ID
- Employer-issued photo ID or Student ID issued by a U.S. college or university
- Tribal enrollment or other tribal photo ID
- A copy of a current utility bill, bank statement, government check, paycheck, or other government document containing the name and address of the voter

* Virginia law permits an expired DMV license to be used for voting purposes.

WHAT IF I FORGET MY ID?

- If you get to your polling place without acceptable ID, you can sign an ID statement affirming your identity and you will be able to vote a regular ballot.
- If you do not sign an ID statement to affirm your identity you may vote a provisional ballot. You will be provided instructions to ensure your vote will count.
